#### Important Note:

#### Deadlines:

- All forms should be submitted by **April 15, 2008**. If your parents will not be able to submit tax returns until a later date, please have them send us a letter detailing when tax returns are due in your country and when the Financial Aid Office will receive a copy. Failure to notify the Financial Aid Office may result in a reduction in scholarship and an increase in loan or employment eligibility.

#### Required Documents:

- The *International Student Financial Aid Application for 2008-2009*.
- Copies of all pages of the latest tax returns filed by your family with your country's government. The tax return for 2007 will be required later to complete your file if not available at the time of application. For students from some countries (for example, Pakistan and India), the final required tax return will be filed in the spring/summer of 2008 for the 2008-2009 assessment year. If your family does not file a tax return, statements from employers certifying earnings and allowances are required.
- If parents are divorced or separated, the above forms are required from both parents.
