

## **SUMMARY ANNUAL REPORT**

### **For The Health & Welfare Benefits Plan of Dartmouth College**

This is a summary of the annual report of the The Health & Welfare Benefits Plan of Dartmouth College, EIN 02-0222111, Plan No. 506, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Trustees Of Dartmouth College has committed itself to pay certain self-insured Medical and Short-term Disability claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Federal Insurance Company, Delta Dental Plan Of New Hampshire, Inc., Cigna Health And Life Insurance Company, ComPsych Corporation, Vision Service Plan, and Lincoln National Life Insurance Company to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$6,408,305.
