Professor Cummings is Senior Lecturer in English Literature at the University of Glasgow

Professor Cummings studied at the Universities of Glasgow (MA) and, as Snell Exhibitioner and Newlands Scholar at Balliol College, Oxford (Blitt); he has held permanent teaching posts at the University of Glasgow since 1967 (as Senior Lecturer since 1989) and is now a Senior Research Fellow. He is co-editor of *Translation and Literature*. His teaching has covered most periods of literature from medieval to modern and most genres.

Professor Cummings has edited *Spenser: The Critical Heritage* and *Seventeenth-Century Poetry* for the Blackwell Annotated Anthology series. He is the author of critical and bibliographical articles, mainly on sixteenth and seventeenth-century British poetry (Gavin Douglas, Drummond, Spenser, Jonson, Herbert, Marvell) but also on eighteenth- and nineteenth-century topics. His interests in neo-Latin literature are reflected in publications on Alciati. He has written on a variety of translation-related topics.

English 31: Reason and Revolution at the 10A hour

Was there a British Enlightenment? In the age of the American and French Revolutions Britain seemed to hold steady. But in the literature of the period there are many social and literary struggles which took their tolls in the madness and suicide of writers such as Smart and Chatterton, the difficulties of attaining creative freedom, and the emergence of new literary forms such as the Gothic. This course will trace the fortunes of writers such as Samuel Johnson, James Boswell, Oliver Goldsmith, and Edmund Burke as they grapple with the anxieties of their time. We will also consider how women thinkers and novelists such as Charlotte Lennox and Mary Wollstonecraft forged new roles for themselves and we may include studies of the novel of political paranoia as exemplified by Caleb Williams, and by Wollstonecraft's husband, William Godwin.
