

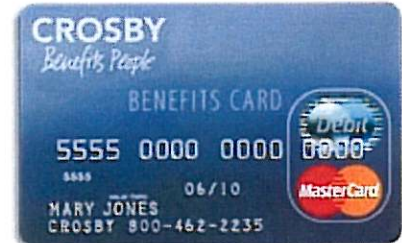

# Use your Crosby Flex Debit Card at the stores listed below and You will not need to submit a receipt!

IIAS (Inventory Information Approval System) technology makes it possible to track which of your purchases are considered eligible under your Medical Flexible Spending Account.

What this means:

- ✓ When you shop at a retailer listed below, at the point of sale, items will be identified as either an “eligible” or “ineligible” FSA expense.
- ✓ Use your Flex Debit Card to pay for eligible items. You will be asked to use another payment method for ineligible items.
- ✓ If your transactions are auto-adjudicated, you will not be asked to submit a receipt to Crosby.
