Request for F-1 Student Program Extension (I-20 Form)

If you will not complete your program of studies by the end date listed in #5 of your I-20 form, you must apply to the Office of Visa and Immigration Services for a Program Extension before that date. Please submit to the Office of Visa and Immigration Services **no later than 30 days prior to the expiration of the original I-20 Form:**

1. **This completed form, signed by your Class Dean or Program Director**
2. **A letter from your Class Dean, faculty advisor, licensed Doctor or Psychologist explaining why additional time is needed. If the letter is from your school or department, it must indicate the new end date and any College funding.**
3. **If you are supporting yourself financially, we will need to see a copy of a recent bank statement as evidence of your personal funds, or for undergraduates, a new financial certification form signed by your parents.**

Please note that failing courses and poor academic performance are not valid reasons for a program extension according to Homeland Security regulations. This extension will not give you a new visa. If you travel outside the U.S., you may need to apply for a new F-1 visa at a U.S. Consulate before re-entering the U.S. This can take form a few days to more than two months, given security clearance delays.

The information being requested is for the purpose of expediting the issuance of an I-20 form extension.

We are required to maintain a record of this extension per INS regulations.
